Chief Supervisor

Essential Functions:

Serves as head of a unit or other major segment in a division. Possess considerable knowledge of utility maintenance, construction and installation of water and sewer systems. Possess great customer service skills. Conduct daily business activities according to the City of Shreveport Policies and Code of Ethics. Monitors work sites to ensure safety standards are met. Maintains job safety standards (personal protection equipment, confined space, shoring trenches, electrical safety, and monthly safety training); possess knowledge of power equipment, etc. Responsible for water/sewer system investigations, operating equipment, assisting with repairs, troubleshooting problems. Conduct follow-up site visits for Request Tracker and citizen issues. Oversee/inspect contractor projects. Perform quality control checks. Demonstrate desire and ability to work in a team environment. Subject to 24-hour emergency call.

Plans, proposes, develops budget estimates, and implements approved work. In charge of training, and safety programs for all team members. Assist in controlling the expenditure of allocated funds. Evaluates staff members on a three, six month and annual basis. Recommends new hires, pay raises, and other personnel actions. Develops cost effective planned maintenance work processes. Assist engineering in projects. Conducts daily work coordination with customers and business owners as necessary. Manage overtime budget and purchase order requests. Promotes teamwork and coordination in completion of tasks. Utilizes computer for spreadsheets, project management, Email, and word processing. Completes work orders and enters in computer daily. Possesses knowledge of personnel rules and regulations. Possesses good decision-making skills.

Maintains records on work labor, accident forms and timecards daily. Operates cell phone, portable radio and electronic e-mail for communications. Possesses knowledge of reading blueprints, and engineering drawings. Complies with and enforces safety rules and regulations. PRE-TREATMENT INSPECTOR

ESSENTIAL DUTIES: Pre-Treatment Inspector work examples:

- 1. Identifying and classifying potential industrial and commercial sources
- 2. Reviewing and evaluating applications from new sources

- 15. Providing compliance assistance to FSE management
- 16. Participating in public outreach and awareness programs

Leads and directs work teams; plans for construction projects; prepares budget proposals; prepares plans for future facility needs; implements improved operational and mechanical procedures; calculates alum chemical dosage in pounds/day; determines feed rates for all treatment chemicals; calculates and adjusts ozone feed rates; performs jar testing; oversees work performed by assigned operators and other workers; monitors water or wastewater pumping, monitors computer systems; monitors all plant processes; performs maintenance repair requirements on all plant equipment; Demonstrates knowledge and use of computerized maintenance management system (CMMS) and related documentation procedures. Initiates work orders.

All Senior Operators will be able to perform any of the tasks required of an Operator and may be called upon to do so if required. Maintains job safety standards (personal protection equipment, confined space, etc.); complies with City of Shreveport vehicle safety rules; trains new team members on safe work practices; maintains good communication with team members. Regularly attends required safety, job related, and certification training classes as required.
