LRWA membership pricing is determined as follows:

**\$375.00 = Population < 10,000:** A water/wastewater system *servicing* less than 10,000, or a municipality with a *population* less than 10,000

**\$400.00 = Population > 10,000:** A water/wastewater system *servicing* 10,000 or more, or a municipality with a *population* of 10,000 or more

**\$400.00 = Industry:** A company/corporation with a water/wastewater facility or managing several water/wastewater systems.

**\$65.00 = Individual:** You must be an employee of a current LRWA member water/wastewater system, associate member, or industry-associated agency who wishes to receive LRWA information at a personal address
